3. ELIGIBILITY

The Competition is open to everyone. All ages and all countries of residence.

Excluded are: directors, officers, officers, employees, agents, agents and representatives of the Contest Organizer, of its parent company, of any company, trust or other legal entity controlled by or related to them, of Facebook if the Contest takes place on Facebook, any participating Store, advertising and promotional agencies, providers of prizes, goods and services in connection with the Contest, as well as immediate family members (siblings, children , father, mother, legal or de facto spouse, notwithstanding their place of residence) of the above-mentioned persons or the persons with whom they are domiciled (whether or not they are related).

6. DRAW

Draw Details: There will be a random selection of an eligible entry from among all valid entries registered during the Contest Period.

7. PRIZE CLAIMS

In order to be declared a winner, any selected participant must:

- a) be reached on social networks, at the sole discretion of the Contest Organizer, within ten (10) days of the draw. Any selected entrant who cannot be reached following appropriate and reasonable steps taken by the Organizer during this period will be disqualified, and a new draw will be made to award the prize;

- d) Failure to comply with one of the conditions mentioned in these rules or to accept the prize, the selected participant will be disqualified. In such event, the Contest Organizer may, at its discretion, cancel the prize or conduct a new draw from the remaining eligible entries until an entrant is selected and declared a winner. If no entrant is declared a winner within sixty (60) days of the original draw, the prize will be forfeited.

Disqualification. The Contest Organizer reserves the right, at its discretion, to cancel an entry in the Contest when the participant posts an inappropriate design (violence, sexuality, or other subject).

- (ii) (i) to have tampered with the entry forms or material, the processing of entries, the running of the Contest or any technical or mechanical element of the Contest, or (ii) to have deliberately damaged the websites, web pages and applications relating to this Contest or having sabotaged the legitimate running of the Contest, or (iii) having violated these rules, or (iv) having used a means contrary to these rules or likely to be unfair towards other participants, or (v) to have obtained registrations beyond the permitted limit, or (vi) to have used multiple names, identities, e-mail addresses and / or any automated system or program to register or participate in the Contest, or (vii) to have disrupted the running of the Contest in any other way, or (viii) to have or acted in an unfair manner or in such a way as to harm or with the intention of annoying, tormenting, threatening or harass another person . Any participant may be required to sign a confirmation to this effect.

By submitting a photograph, musical piece, creation or other type of work (the "Work") in the context of this Competition, the participant guarantees that the Work is free of all rights of third parties and the participant guarantees to hold the rights necessary to submit the work as well as, in particular but without limitation, to authorize the Organizer to use, modify, transfer, adapt, disseminate, communicate or distribute it, on any dissemination medium, media or technology whatsoever, including but not limited to television, information technology, wireless or online. The participant agrees to provide, on request, proof of the rights he holds in the Work and he indemnifies the Organizer in the event of any claim, demand, lawsuit, dispute arising from any type of use of the Work.

Property.

All information and documents related to the Contest, including but not limited to, entry forms, coloring drawings, technical, technological or operational information and information relating to designs, computer systems, software, logos, trademarks and intellectual property, are and remain the exclusive property of the Contest Organizer. None of this information and documents will be returned to participants.

Identification of the participant.

For the purposes of these rules, the participant is the person who posts the design on social networks and it is to this person that the prize will be awarded if selected and declared a winner.

Decision of the Contest Organizer.

Any decision by the Contest Organizer or its representatives relating to this Contest is final and without appeal.

Facebook / Instagram.

Various.
